Still Concerning Times – Financially

The past year continued to be "slow-rebound" times financially for WNCA. The interest we earn on our perpetual funds has continued to be very low, and we are always at risk of drawing down on some of the principal held in CDs for

annual care. Fortunately, though some of our principal has been in holdings that took a 10-15% hit during the worst of the crisis, the key culprits have been trending upward again. As always, every donation to our perpetual fund is a greatly appreciated help in meeting necessary annual maintenance and beautification expenses while increasing the prospect of "growing" the Fund for improvements. The O'Brien Property Update

The 55' strip of land to the east of the cemetery donated by the developer of the O'Brien property continues to be a subject of discussion. We purchased two granite corner markers to ensure there will be no unintentional encroachment. We also will be contacting the developers to let them know they can deposit any foundation dirt behind the wall in order to build it up to the level of the cemetery. While there are no plans to expand the cemetery proper in the foreseeable future, we are just grateful that this "buffer" is now "ours."

Abandoned Burial Plots

We continue with our initiative to inventory abandoned plots that will be reacquired by the WNCA for purchase. These plots will be reacquired by the WNCA according to guidelines that meet or exceed state statutory requirements.

Interesting Research Discoveries

In following the website's genealogical links for some of the original plot owners, the Rogers family connections have shed light on three 18th century brothers, **Jonathan**, **Nathan**, and David Rogers, their forebears and descendants. These brothers represent the fourth generation living here and the first generation interred in the Old Rogers Cemetery; some of their descendants were "removed" to West Neck Cemetery. Their Great Neck Rogers forebears are buried ???

David's grandson David (lot 65) was a deacon at the Seventh Day Baptist Church who, along with Oliver Maxson (lot 44), sold the cemetery its original acre and helped found the Association. He also left land for the current Seventh Day Baptist Church so long as it remains used by the Church. His son David (lot 61) supervised the construction of the existing cemetery wall, and his daughter Charlotte married Thomas Greenman of Mystic; they purchased lot 62, but used Mystic's Elm Grove Cemetery instead. One of Charlotte's four granddaughters was Mary (Stillman) Harkness, who, with her husband, Edward, returned Goshen Point to Rogers-line family ownership—it is now enjoyed by all as Harkness State park! The Harknesses commissioned the Greenman Chapel at Elm Grove in memory of Great Neck native Charlotte. And Mary made a generous donation in 1927 for upkeep of the "David Rogers Lot." Who knew?

A lot to digest – and reason to discuss "reconnecting" with the Old Rogers cemetery by considering historical plaques for both cemeteries. Come to the meeting for more!

Annual Meeting Announcement: Spread the Word!


Sunday, April 25th, 2010 at 4:30 PM
